
The Chairman of the Investigative Committee of Russia gives a number of instructions over incidents in regions



The Chairman of the Investigative Committee of Russia requested a report on progress of investigation of a probe into a road accident with a passenger bus in Saratov Region. As a result 12 persons were injured, 6 of which were hospitalized. According to preliminary data, on August 9, 2021, at about 2 am on the 620th kilometer of the P-22 "Kaspiy" road near the village of Bolshaya Olshanka, Kalininsky District, the driver of a passenger bus traveling from Belgorod to Saratov lost control, as a result of which the vehicle overturned into a ditch.

Alexander Bastrykin also requested a report on circumstances of a recent traffic accident with a car of the Investigative Committee.

Apart from that, the Chairman of the Investigative Committee of Russia requested a report on the progress of a pre-investigative inquiry into a possible violation of rights of widow of an entrepreneur

in the Republic of Bashkortostan who applied to the Committee through mass media sources asking to sort the situation out.

Also, Alexander Bastrykin requested a report on the progress of pre-investigative probe upon a report about inadequate provision of care services for a 95-year-old pensioner in the Sverdlovsk region.

Apart from that, Alexander Bastrykin requested information on beating of a senior man in Lubertsy.
