## **The Chairman of the Investigative Committee of Russia requested reports on a number of incidents with children**



Chairman of the Investigative Committee of Russia instructed the acting head of the Novosibirsk Regional Investigative Department of the Investigative Committee of Russia A.N. Badulin to report on the progress of the criminal investigation into the death of a child born in 2018 in the Novosibirsk region (Part 2 Article 216 of the Criminal Code). Preliminarily it was found that a man, driving a tractor, performed the work of mowing the grass on the roadside of the street territory in the city of Karasuk, Novosibirsk region. In the course of the work the tractor driver injured a little boy, who was on the side of the road. As a result of the accident, the child died on the spot. The progress of the investigation is under supervision of the Central Office of Investigative Committee.

In addition, Chairman of Investigation Committee of Russia requested from the head of the Moscow Regional Investigative Department of the Investigative Committee of Russia A. Yu. Starikov a report on the progress of criminal investigation into the negligence of officials that resulted in attack

of dogs on child in Nikolskoye village of Dmitrovsky urban district (Part 1 of Article 293 of the Criminal Code). According to investigators, on August 25, 2021 a 7-year-old boy was attacked by stray dogs. The boy was hospitalized with bite wounds to the hospital, where he was given the necessary medical care. The progress of the investigation is under control in the central office of the Investigative Committee.

Chairman of Investigative Committee of Russia also instructed the head of the Leningrad Regional Investigative Department of the Investigative Committee of Russia S. T. Sazin to report on the investigation of the criminal case of attempted murder of a minor in Vsevolozhsky area of Leningrad region (Part 3 of Article 30, Paragraph C of Part 2 of Article 105 of the Criminal Code of Russia). According to investigators, August 25, 2021 a 24-year-old man, staying with a young child of his acquaintance, with whom he lived together, in his apartment, feeling resentment toward the girl in order to kill her, struck many blunt object in the head, torso and extremities of the victim. The man was detained. He was charged. The issue of his preventive measure in the form of custody is being resolved. The progress of the investigation is under control of the Central Office of the Investigative Committee.

Chairman of Investigative Committee of Russia requested a report from the head of the Yaroslavl Regional Investigative Department of the Investigative Committee of Russia A. M. Sobolev on the progress of investigation of the criminal case into the death of a 3-year-old girl (Paragraph C of Part 2 of Article 238 of the Criminal Code). According to investigators, on August 26 on Tutaev highway in Yaroslavl the driver of a passenger bus hit a 3-year-old child. The girl was hospitalized in a medical institution, where as a result of the injuries she died in the intensive care unit. The progress of the investigation is under supervision of the Central Office of the Investigative Committee.
