## **The Chairman of the Investigative Committee of Russia gives a number of instructions over information reported by mass media**



Chairman of the Investigative Committee of Russia instructed the head of the Moscow Regional Investigative Department of the Investigative Committee of Russia A. Starikov to report on the progress of the verification of information from the media about the commission of illegal actions by a kindergarten teacher in respect of a 5-year-old child. The Moscow Regional Main Investigative Department of the Investigative Committee of Russia organized an additional assessment into this matter. It is reported that a kindergarten teacher in Gorki-10 during quiet time wrapped a five-year-old boy's arms and legs with clerical tape, and then after a short period of time she removed the tape from the child. The progress of the assessment is under the supervision of the Central Office of the Investigative Committee of Russia.

In addition, I. V. Kolesnichenko, acting head of the Alta Regional Investigative Department of the Investigative Committee of Russia was instructed to report on the investigation of the criminal case

of causing grave harm to health by negligence to a teenager (Part 1 of Article 118 of the Criminal Code of Russia). According to investigators, on September 5, 2021 in the town of Gornyak, a 14-year-old was on the property with two peers. One of his friends doused his friend's clothes with gasoline out of pranks, and after a while set fire to a lighter in the immediate vicinity of the young man. As a result of the incident, the victim received 50 percent body burns and was taken to a medical facility. At present the life of the child is out of danger. The progress of investigation is under the supervision of the Central Office of the Investigative Committee of Russia.

The Chairman of the Investigative Committee of Russia instructed the head of the Sverdlovsk Regional Investigative Department of the Investigative Committee of Russia M.V. Boginsky, to report on the circumstances of the attack committed, according to media reports, by a drunken man on a family with a disabled son in the Sverdlovsk region. It was reported that in Yekaterinburg, an intoxicated man broke into a neighbor's apartment and opened fire with a shotgun; no one was injured.

The head of the Committee ordered the head of the Samara Regional Investigative Department of the Investigative Committee of Russia Galikhanov M.F. to report on possible violations of children's rights voiced on the air of a federal channel. It was reported that in a family from Togliatti, after a divorce and contrary to the court order, the ex-husband took his children and refuses to return them to his wife. The Regional Investigative Department of the Investigative Committee of Russia is conducting a check on the fact of kidnapping and illegal retention of his minor children by a man. The progress of the assessment is under the supervision of the Central Office of the Investigative Committee of Russia.

In addition, in connection with various publications in the media and social networks critical of the deputy head of the Stavropol Regional Investigative Department of the Investigative Committee of Russia A. Demin, the head of the Committee instructed the Central Office of the Investigative Committee of Russia to conduct an official check in relation to him.

The results of the investigation are to be supervised by the Central Office of the Committee.
