
The Chairman of the Investigative Committee of Russia gives a number of instructions over information reported by mass media



In connection with the appeal to the leadership of the Investigative Committee of Russia of female residents of Sverdlovsk region in a criminal case of possible negligence of doctors of one of the Sverdlovsk medical institutions, the Chairman of the Investigative Committee of Russia instructed the head of the Sverdlovsk Regional Investigative Department of the Investigative Committee of Russia Boginsky M.V. to report on the progress of criminal proceedings initiated earlier under Part 1 of Article 293 of the Criminal Code. In addition, a report was requested on the verification of the death of a man who was being treated at the hospital.

Also, the head of this investigative department was instructed to report on the circumstances of injury to a resident of an apartment building in Yekaterinburg as a result of a gas-air mixture explosion. Investigative units of the Investigative Committee of Russia are conducting an investigation into this incident, and measures are being taken to clarify all the circumstances.

The head of the Krasnodar Regional Investigative Department of the Investigative Committee of Russia A.K. Maslov was instructed by the Chairman of the Investigative Committee of Russia to report on the circumstances of the accident involving a passenger bus near Kavkazskaya village, which resulted in injuries to passengers. The territorial department of the Investigative Committee of Russia immediately launched a pre-investigative probe into this matter. According to reports, at the 113th kilometer of the federal highway "Kavkaz" there was a traffic accident involving a bus going from the Stavropol Territory to the Republic of Crimea and a truck. At the time of the accident, the bus was carrying students from one of the universities. According to the available information, as a result of the accident several passengers and the bus driver were injured and taken to hospital for necessary treatment.

The Chairman of Investigative Committee of Russia instructed the acting head of the Investigative Department of the Investigative Committee of Russia for Krasnoyarsk region and Republic of Khakassia A.G. Zyubanov to report on investigation of criminal case of illegal imprisonment of district general practitioner (Paragraph D of Part 2 of Article 127 of the Criminal Code of Russia). According to investigators, on August 09, 2021 a local therapist came to one of the apartments in a house in Krasnoyarsk to provide medical care to a woman. Having completed the examination and provided medical assistance, the doctor was about to leave the apartment, but the woman's grandson locked the front door in the apartment, restricting the doctor's free exit, and inflicted at least eight stabbing blows on various parts of her body, depriving her of freedom of movement. The man was detained, the court ruled to place him into custody. The perpetrator was charged with the crime and during the interrogation he partially confessed

In addition, the head of the department instructed the head of the Yaroslavl Regional Investigative Department of the Investigative Committee of Russia to report on the ongoing investigation into the information voiced in the broadcast of the federal channel, about the commission of possible fraud and illegal actions against a 51-year-old man from the Yaroslavl region by the head of the charitable foundation.

A similar instruction was given to the head of the Main Investigative Department of the city of Moscow, A.A. Strizhov. Investigators are to report on the progress of the check on media information about a family conflict that left a single father and his young daughter on the street, who were kicked out of their apartment by relatives.
