
The head of the Investigative Committee of Russia gave a number of instructions on information about violations of the rights of children and socially unprotected citizens



Alexander Ivanovich Bastykin instructed the head of the Krasnodar Territorial Investigative Department of the Investigative Committee of Russia A.K. Maslov to report on the circumstances of injuries to a young boy in a private kindergarten. On September 8, 2021 a 2-year-old boy was injured by other children in the form of bruises and abrasions while in a private kindergarten. The boy was rendered the necessary assistance by his teachers on the spot. The investigative department launched a probe into this fact.

In addition, the Chairman of the Investigative Committee of Russia instructed the head of the Tambov Regional Investigative Department of the Investigative Committee of Russia Polshakov A.N. to report on the progress of the criminal investigation into the accident that killed a little girl. On September 9, 2021 the suspect, being in a state of intoxication, driving a car, hit two schoolgirls. The 11-year-old girl died at the scene of the accident, and her 13-year-old friend was hospitalized at

Children's Regional Hospital with various injuries. The suspect's 51-year-old father, who was in the car with him at the time of the accident, was also taken to a medical facility. Currently, the suspect is detained, the investigation petitioned the court for a measure of restraint in the form of detention. The progress of investigation of the probe is under the supervision of the Central Office of the Investigative Committee of Russia.

The head of the Investigative Committee of Russia instructed the head of the Chelyabinsk Regional Investigative Department of the Investigative Committee of Russia Reshetnikov P.G. to report on the investigation of the criminal case on the murder of a little girl who was strangled by her mother's cohabitant. The suspect in the commission of this crime has been identified and detained, the progress of the investigation is under control in the Central Office of the Investigative Committee. Also Reshetnikov P.G. was instructed to report on the progress of the investigation, initiated by the materials of the media, on the fact of finding a 5-year-old boy frozen alone in the street. The progress of the assessment is under the supervision of the Central Office of the Investigative Committee of Russia.

Also in the media there were reports that in one of the districts of Novosibirsk a wheelchair person is forced to walk on a ramp installed by his father, as the passage to exit to the site of the neighboring house is blocked. The Novosibirsk Regional Investigative Department of the Investigative Committee of Russia launched a procedural probe into this information. Alexander Ivanovich Bastrykin instructed the acting head of the Novosibirsk Regional Investigative Department of the Investigative Committee of Russia to report on all circumstances of the incident; the progress of the assessment in under supervision of the Central Office of the Investigative Committee of Russia.

A similar situation arose in Lipetsk Oblast, where a family raising a 10-year-old child with a severe genetic disease was not provided with a ramp. The Lipetsk Regional Investigative Department of the Investigative Committee of Russia launched a procedural probe into this matter. The Chairman of the Investigative Committee of Russia instructed the head of the Lipetsk Regional Investigative Department of the Investigative Committee of Russia to report on circumstances of violation of rights of the child; the progress of the assessment is supervised by the Central Office of the Investigative Committee of Russia.
