## The Chairman of the Investigative Committee of Russia instructed to report on the progress of a procedural probe and investigation of a number of probes



On October 14, 2021 law enforcement bodies received a report about discovery of the body of a 14-year-old girl with signs of violent death in a settlement of Chita. On this fact, the Transbaikal Territorial Investigative Department of the Investigative Committee of Russia opened a criminal case on the grounds of corpus delicti under Part 1 of Article 105 of the Criminal Code of Russia (murder). A 15-year-old local resident was detained on suspicion of committing the offense. Alexander Ivanovich Bastrykin put the investigation of the criminal case under supervision of the Central Office of the Investigative Committee and instructed the head of the Transbaikal Territorial Investigative Department of the Investigative Committee of Russia Rusanov Yu.S. to submit a report.

The Chairman of the Investigative Committee of Russia instructed the head of the Main

Investigative Department of the Investigative Committee of Russia for the Republic of Crimea and the city of Sevastopol Terentyev V.N. to report on the progress of the check on the information about the unsatisfactory attitude of the medical staff of the Republican children's infectious hospital to a 17-year-old Crimean resident being treated after a traffic accident. The progress of the probe is under the supervision of the Central Office of the Investigative Committee of Russia.

In addition, in connection with the published appeal to the leadership of the Investigative Committee of Russia with a request to pay attention to the investigation of the criminal case against Vinenko N.V. under Part 4 of Article 159, Paragraph B of Part 4 of Article 174.1 of the Criminal Code of Russia, the Chairman of the Investigative Committee of Russia instructed the head of the Investigative Department of the Investigative Committee of Russia in the Kirov Region A.P. Vinogradov to submit a progress report on the investigation. According to investigators, N.V. Vinenko failed to appear on the appointed day for investigative actions, thereby violating the measure of restraint elected against him in the form of a written pledge not to leave the city and to behave properly. Subsequently, he was put on the federal wanted list, since he escaped from the investigating authorities and tried to leave the territory of the Russian Federation, purchasing air tickets for 10/14/2021 with a flight from Krasnodar Territory to Yerevan, Republic of Armenia and, having arrived at the airport of Krasnodar, however, his actions were intercepted by police officers as part of the execution of the search order. At present, officers of the Ministry of Internal Affairs of Russia in the Kirov region are transporting the accused from Krasnodar to the Kirov Regional Investigative Department of the Investigative Committee of Russia for his arrest.
