
The Chairman of the Investigative Committee of Russia gives a number of instructions over information reported by mass media



During the monitoring of the media and the Internet a publication about the improper performance by a resident of the city of Togliatti of her duties to raise her newborn child was found. According to the published information, the woman prevented her son from receiving the medical care necessary for his age, the child did not receive sufficient food, and lived in unsanitary conditions. The Samara Regional Investigative Department of the Investigative Committee of Russia is conducting an investigation into the fact of improper performance of their duties by officials of bodies of prevention. In addition, a criminal case was immediately initiated against the mother of the child suspected of committing a crime under Article 156 of the Criminal Code (failure to fulfill the duties of bringing up a minor). The Chairman of the Investigative Committee of Russia instructed the head of the Samara Regional Investigative Department of the Investigative Committee of Russia, M.F. Galikhanov, to report on the progress of verification measures.

In addition, the story of the unknown disappearance of an 18-year-old girl from the Altai region was discussed on the air of the federal channel. The Altai Regional Investigative Department of the

Investigative Committee of Russia is investigating a criminal case into this matter initiated under Part 1 Article 105 of the Criminal Code. According to investigators, on the night of September 9-10, 2021, the wanted went out of the house, and so far her whereabouts have not been established. The woman has a young child to raise. The head of the department instructed the acting head of the investigative department of the Investigative Committee of Russia for Altai Territory I.V. Kolesnichenko to report on the conducted investigative and operational-search activities in the criminal case. The progress of investigation is under supervision of the Central Office of the Investigative Committee of Russia.

In addition, the Chairman of the Investigative Committee of Russia instructed the head of the Tomsk Regional Investigative Department of the Investigative Committee of Russia Shchukin A.V. to report on the progress of the criminal investigation into the criminal case initiated over the discovery of the man's body in the woods of Molchanovsky district of Tomsk region. The progress of investigation is under supervision of the Central Office of the Investigative Committee of Russia.

It was also reported in the media that a woman who was involved in the census campaign was brutally beaten in Kazan. A resident of one of the houses, according to the victim, struck her, which caused the scribe to fall down the stairs and end up in the hospital with a fracture. The Chairman of the Investigative Committee of Russia instructed the head of the Tatarstan Republican Investigative Department of the Investigative Committee of Russia Lipsky V.A. to report on the situation.

In addition, social media monitoring revealed a message indicating the need to check one of the retail spaces located in the Rostov Region. Users report possible non-compliance with fire safety standards by the owners. The Chairman of the Investigative Committee of Russia instructed the head of the Rostov Regional Investigative Department of the Investigative Committee of Russia Huade A.G. to report on the situation.
